## Promotional Campaigns Nido Student Germany 2021

### Generally applicable terms & conditions of our promotions

- Any natural person who is at least 18 years old can take part in our campaigns.
- A cash payment, bank transfer or a payment to someone other than the tenant is not possible.
- Multiple bookings from one person cannot be taken into account.
- Violations of the conditions of participation lead to exclusion.
- The reduction does not apply in the event of an early move-out due to the provision of a new tenant or a termination during the rental period.
- The entire agreed period of residence must be fulfilled.
- The promotions apply to bookings made via the Nido Student online reservation system, by phone or in person in one of the Nido student residences, depending on availability.
- To be eligible for the promotion, the booking must be confirmed and all required payments must have been received.
- The renter must have received a booking confirmation by email for the promotion to be valid.
- Nido Student reserves the right to terminate, change or extend promotions at any time.

### § 1 – General

Participation in campaigns can only take place if these conditions of participation are met. Nido Student is a brand of Nido Management Germany GmbH, Potsdamer Platz 8, 10117 Berlin.

### § 2 – False Information

Participation is only possible in your own name. Entering incorrect or third-party data (name, address, e-mail address, bank details, etc.) leads to exclusion from the campaign.

### § 3 - Privacy

The organizer guarantees the highest possible data protection standard and complies with all relevant legal provisions. The organizer will not pass on any personal data to third parties or sell address data. The organizer stores the personal data of the respective participants exclusively for the purpose of the campaign. The participant hereby expressly consents to the storage and use of the personal data provided for the above-mentioned purpose. You can read more about our [privacy policy here](#).

#### **§ 4 – Actions in the event of an interruption of a promotion**

The organizer reserves the right to change, cancel or end the promotion for objective reasons at any time and without prior notice. A factual reason is given in particular if the action cannot (no longer) proceed according to plan (e.g. infection of computers with viruses, software or hardware errors or other technical, factual or legal reasons that hinder the administration, security, integrity or the proper execution of the action). The organizer decides at its own discretion whether the promotion can be continued in a modified form or whether it should be canceled or ended early.

#### **§ 5 - Liability**

According to the current state of technology, data communication via the Internet cannot be guaranteed to be error-free and available at all times. The organizer is therefore neither liable for the constant and uninterrupted availability of the online systems used by him nor for technical and electronic errors in a telemedia service over which he has no influence, in particular not for disruptions such as loss, delay, change, manipulation or misdirection of e-mails originating from external data networks, external telephone lines or other hardware or software belonging to the participants or third parties. The same applies to disruptions in the input, acquisition, transmission and storage of data, in particular for incorrect, missing, interrupted, deleted or defective data records. Furthermore, no liability is assumed if e-mails or data entries do not meet the requirements specified there and as a result are not accepted or accepted by the system. The organizer is also not liable in the event of theft or destruction of the systems or storage media on which the data is stored. The same applies to unauthorized changes or manipulation of the data by the participants or third parties.

The organizer is only liable for damage other than injury to life, limb and health insofar as these are based on willful or grossly negligent behavior on the part of him or his vicarious agents. In the event of a culpable breach of an essential contractual obligation, the organizer is also liable for negligent breaches of duty. Essential contractual obligations are those obligations, the fulfillment of which makes the proper execution of the contract possible in the first place and on whose compliance the participant can regularly rely. In this case, however, liability is limited to the foreseeable damage typical for the contract. Any further liability is excluded.

#### **§ 9 - Severability clause**

Should individual provisions of these conditions of participation be ineffective or a loophole exist, this does not affect the effectiveness of the remaining provisions. The ineffective or missing provisions must be replaced by a provision that comes closest to the purpose of the contract and the statutory provisions.

## **Additional applicable terms & conditions for the "Early Bird – Winter 2021" promotion**

### **§ 1 – General**

Participation in the "Early Bird - Winter 2021" campaign for all Nido Studios on our website can only take place if these conditions of participation are met. Nido Student is a brand of Nido Management Germany GmbH, Potsdamer Platz 8, 10117 Berlin.

### **§ 2 – Conditions of participation**

All natural persons and persons who are at least 18 years old are eligible to participate. Registration takes place by concluding a rental contract from a rental start on September 1st, 2021 or October 1st, 2021. The currently displayed prices on the website and in the booking portal always apply to bookings. For bookings made after an adjustment, there is no entitlement to older rental prices.

### **§ 3 – Further conditions of participation**

The prerequisite for effective participation is the valid conclusion of a rental contract, the expiry of the cancellation period and the move into the person's apartment in one of our Nido Studios.

### **§ 4 – Promotion**

The "Early Bird - Winter 2021" campaign runs from April 15, 2021 to April 30th, 2021. The prerequisite is that a new rental agreement is concluded in the specified period, provided that the conditions mentioned under §2 and §3 are met. Rental contracts can be booked exclusively at currently lower prices for a short time during this promotion before the new rental prices for the Winter Semester 2021/22 appear live on the website. The promotion is ONLY valid if a rental agreement is signed online via the website [www.nidostudent.de](http://www.nidostudent.de). The organizer has the right to extend or shorten the promotional period at its own discretion.
